

## **BECKERS LIMITED PAINT WARRANTY**

Beckry®Tech Super Durable Polyester Coil Coating System forty (40) years limited warranty, for goods used on wood frame buildings and on architectural, commercial, pre-engineered or residential metal buildings, which are installed within the Continental United States, Alaska and Canada. Beckry®Tech Super Durable Polyester Coil Coating System, when properly applied as per the Technical Data Sheet to HDG steel, Zinc-Aluminum Alloy steel (in a vertical application) will meet the following standards from the date of installation:

- WILL NOT crack, check or peel (lose adhesion) for forty (40) years. This does not include minute fracturing which may occur in proper fabrication of the building parts such as crazing or slight cracking.
- WILL NOT chalk in excess of ASTMD-4214 method seven (7) rating at any time for thirty (30) years.
- WILL NOT change color more than six (6) Hunter delta E units as determined by ASTMD-2244 method for thirty (30) years. Color change shall be measured on an exposed painted surface that has been cleaned of surface soils and chalk, and compared to the original or unexposed painted surface. It is understood that fading or color changes may not be uniform if the surfaces are not equally exposed to the sun and elements.

If our Beckry®Tech Super Durable Polyester Coil Coating System fail to comply with our limited Warranty, Beckers will, as Customer's exclusive remedy hereunder, pay for labor and material reasonably necessary to repaint, repair or replace, at Beckers' option, the metal panels displaying the defective conditions, provided that Beckers' obligation shall not exceed the lesser of the original purchase price of the affected metal panels (not including any accessories or attachments). In no event shall Beckers be liable for any incidental or consequential damages. In order for the warranty to be in effect, you must notify us in writing of the failure within thirty days of the discovery of such problem and provide access to us and assist us as necessary in determining the exact cause of the failure.

Our LIMITED WARRANTY DOES NOT APPLY to circumstances which we do not control, including:

- Fire or other casualty or physical damage;
- Unusual harmful fumes or foreign substances in the atmosphere, standing water, or direct salt spray;
- Misapplication of Beckry®Tech Super Durable Polyester Coil Coating System (that is, the coating was not applied in accordance with our specifications and instructions as outlined on our product data sheets);
- Damage due to abrasive or chemical cleaners;
- Improper treatment of or defects in the metal or in the fabrication; and
- Mishandled Products, e.g., any product which has been abused, altered, modified, used in a manner not originally intended, or improperly stored. Including a) damage to the product occasioned by condensation attributable to improper packaging, handling, shipping, processing, and/or installation; b) damage due to failure of the substrate.
- Some colors may not meet our high standards. So the Warranty applies only to colors that are approved by Beckers.

For our Warranty to apply, you must maintain certain records. You need to make them available to us for inspection and copying. These are:

- Records necessary to identify the Beckry®Tech Super Durable Polyester Coil Coating System involved in a complaint. (Information that will allow us to obtain batch number and application date from your coater).
- Normal production records and quality control records from your coater of tests required by our specifications. It will be necessary for us to visit your coil coaters facility from time to time to observe their procedures in applying Beckry®Tech Super Durable Polyester Coil Coating System. So, your coater must make their facility available at reasonable times for our visits.
